Where do these data come from?

Items in this chapter regarding Medication come from administrative sources.

Items in this chapter are a part of the NCI Health, Welfare, and Rights domain (Medication topic area) and comprise the "Medication" sub-domain (a specific area of concern within the domain). The Medication subdomain includes items that help determine whether "medications are managed effectively and appropriately". Read more about NCI domains and subdomains in the Overview chapter or this report.

What are "collapsed" data?

Many questions in the IPS allow respondents to answer a question with "middle" response like "maybe", "sometimes" or "in-between". The tables in this section present collapsed data. That means that two or more response options are grouped together if they are considered to reflect a positive outcome. The table titles explain which options were grouped.

To see the breakout of responses for each option, please see Appendix C.

What is weighting and why do we do it?

The NCI averages are "weighted" to reflect the states' relative population and sample sizes. We created the weights using the state's number of valid surveys and its total survey-eligible population. This way, a state that provides services to a larger number of people but uses a sample similar in size to other states has a greater influence on the overall NCI average (that is, its contribution is proportional to its service population).

Some states—in this survey year, IN, MN, TX and WI intentionally oversampled one or more subpopulations or geographical regions to get more focused insights, so their weights are calculated slightly differently (using the number of completed surveys and service population sizes in each subpopulation or region). You can read more about this in the Methodology section of the Overview chapter.

The number of respondents (N) for each question is not weighted.

DATA CAUTION!

Several states had large amounts of missing data or data recorded as "don't know." Where 25% or more of a state's sample had "don't know" or missing responses, we used an asterisk (*) to indicate that state's data should be interpreted with caution as it may not accurately represent the sample or service population.

Note. For those surveyed from RI's SDS service delivery model, there are no administrative records available from which to pull much of the background information. Therefore, the RI data from the background information section may not be representative of this population.

Presentation of state and weighted **NCI** averages

Averages

For the most part, the state outcomes are shown in descending order of percentage and are categorized as statistically significantly above the NCI Average, within the range of the NCI Average, or significantly below the NCI Average. Statistical significance is taken to be at or below the .01 level. For those states that fall within the NCI Average range, their 'always' or 'yes' response was not statistically different from the NCI Average. Other tables show the states listed in alphabetical order and are not tested for significance.

Tables that show significance also break out average results for each state by the type of residence: ICF/IID or other institutional settings, group residence, own home, parent/relative's home, foster or host home. Figure A on the following page shows, by state, the percentage of people surveyed in each residence type. Please note though that:

- Significance testing was not performed on the breakouts by residence
- The number of people in each residential setting is often too small to allow for valid stateto-state comparisons
- And in many cases, statistically valid conclusions cannot be drawn about differences in results between residence types

Still, we provide this information for states' internal purposes. It should not be used to compare one state with another.

To protect people's privacy, we do not show the data when fewer than 20 people from a state or residence type responded to a question (though their responses are included in the NCI average).

Due to the high rate of missing data and "don't know" responses, some tables in this section are shown

twice. The first table illustrates data as typically reported (by significance tier and averages in descending order, excluding missing data and "don't know" responses). The second table shows data in alphabetical order and includes the percentage of missing and "don't know" responses. Data in both sets of tables are weighted.














