Sampling

Each state is instructed to attempt to complete surveys with a random sample of individuals over the age of 18 who are receiving at least one publicly funded service besides case management. States must complete surveys with a sample that meets the 95% confidence level and +/- 5% margin of error based on the total eligible population in the state. A sample size of 400 guarantees valid comparisons to be made across states with a 95% confidence level and a margin of error of +/- 5%, no matter how large the service population size. A 95% confidence level and a margin of error of +/-5% is mandatory for each state's sample to be included in this report. Most states sample more than 400 individuals to account for refusals and surveys that may be deemed invalid.
